KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT is made on the AUG 08 2025 day of 2025 by and between:

DAVAO DEL SUR STATE COLLEGE, a government institution duly organized and existing under and by virtue of the laws of the Republic of the Philippines with official address at Barangay Matti, Digos City, Davao del Sur, duly represented herein by the College President **AUGIE E. FUENTES, Ph. D.**, hereinafter called the "**ENTITY**";

and

KYDE CONSUMER GOODS WHOLESALING, a private company duly organized and existing under and by virtue of the laws of the Republic of the Philippines with official address at Brgy. Western Wao, Wao, Lanao del Sur, duly represented herein by **KIM GREGOR B. DANLOG**, Proprietor, hereinafter referred to as "**SUPPLIER**";

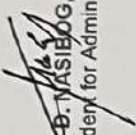
WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly "**Provision of Higher Education Services: Procurement of ICT And Science Laboratory Equipment Negotiated Procurement: Two-Failed Biddings: Lot 2 – Supply, Delivery and Installation of Environmental Science Laboratory Equipment Bundles**" with contract identification number **DSSCPSU 2025-04-06-B** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO HUNDRED NINETY-FIVE THOUSAND PESOS (Php 295,000.00)** Therein after called "the Contract Price").

NOW THIS AGREEMENT WITNES SETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **TWO HUNDRED NINETY-FIVE THOUSAND PESOS (Php 295,000.00)** or such other sums as may be ascertained, the **SUPPLIER**, agrees to faithfully perform the delivery and installation in accordance with its Bid.
4. The **ENTITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

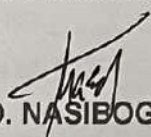
